- Do not use a ramp inclined at more than 10 degrees.
- When the rack cabinet is in the new location, complete the following steps:
 - Lower the four leveling pads.
 - Install stabilizer brackets on the rack cabinet.
 - If you removed any devices from the rack cabinet, repopulate the rack cabinet from the lowest position to the highest position.
- If a long-distance relocation is required, restore the rack cabinet to the configuration of the rack cabinet as you received it. Pack the rack cabinet in the original packaging material, or equivalent. Also lower the leveling pads to raise the casters off of the pallet and bolt the rack cabinet to the pallet.

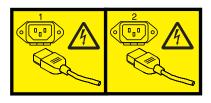

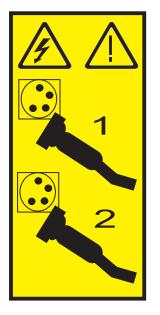

Removing and installing a disk drive

You can service a disk drive concurrently.

- Attach a wrist strap to an unpainted metal surface of your hardware to prevent electrostatic discharge (ESD) from damaging your hardware.
- If you do not have a wrist strap, before removing the product from ESD packaging and installing or replacing hardware, touch an unpainted metal surface of the system for a minimum of 5 seconds.
- Keep all electronic components in the shipping container or envelope until you are ready to install them.
- If you remove and reinstall an electronic component, temporarily place the component on an ESD pad or blanket, if available.

To remove a disk drive from the disk drive enclosure, complete the following steps:

- 1. Slide the orange release latch up gently to unlock the drive handle.
- 2. Grasp the handle and pull the drive partially out of the slot.
- **3**. Grasp the front of the disk drive and pull it out from the slot, making sure that you support the bottom of the disk drive.

Note: The concurrent maintenance light for the slot turns off when you remove the disk drive.




Figure 1. Removing a disk drive from the disk drive enclosure

To install a disk drive in the disk drive enclosure, complete the following steps:

1. With the handle in the unlocked position, support the bottom of the disk drive as you align it with the guide rails in the disk drive enclosure.

Note: Do not hold the disk drive only by the handle.

- 2. Slide the disk drive into the disk drive enclosure until the drive stops.
- 3. Rotate the handle to the locked position.




Figure 2. Installing a disk drive in the disk drive enclosure

Removing and installing an enclosure services manager

You can remove and install an enclosure services manager (ESM) concurrently only when its amber fault light is on solid.

Attention: Failure to follow the steps sequentially for this field replaceable unit (FRU) removal or installation might result in damage to the FRU or system.

Use the following precautions whenever you handle electronic components or cables:

- Attach a wrist strap to an unpainted metal surface of your hardware to prevent electrostatic discharge (ESD) from damaging your hardware.
- If you do not have a wrist strap, before removing the product from ESD packaging and installing or replacing hardware, touch an unpainted metal surface of the system for a minimum of 5 seconds.
- Keep all electronic components in the shipping container or envelope until you are ready to install them.
- If you remove and reinstall an electronic component, temporarily place the component on an ESD pad or blanket, if available.
- During nonconcurrent replacement, do not combine the replacement of any ESM with the replacement of the midplane unless there has been a power cycle of the disk drive enclosure with one new FRU at a time. If multiple FRUs are replaced at the same time, the serial number is not preserved.

To remove and install an ESM, complete the following steps:

- 1. Determine whether the repair can continue concurrently. To continue the repair concurrently, the following conditions must be true:
 - A second ESM must already be installed.

- The amber fault light of the failing ESM must be solid on.
- 2. If any of these conditions are not true, continue the repair only after powering off the unit containing the FRU that is being repaired, and begin with **The ESM will be serviced nonconcurrently**. Otherwise, continue with **The ESM will be serviced concurrently**.
 - **The ESM will be serviced concurrently**. Go to step 3.
 - The ESM will be serviced nonconcurrently. Power off the system or partition that is using the disk drive enclosure. Remove power from both power supplies of the disk drive enclosure. Go to step 3.
- **3**. Remove the ESM:
 - a. Disconnect the serial-attached SCSI (SAS) cable or cables from the ESM and mark each cable label with its location.

Attention: Incorrect cable placement might result in data loss.

- b. Open the two release levers.
- c. Support both sides of the ESM while you slide it out of the enclosure.




Figure 3. Removing an ESM from the disk drive enclosure

- 4. Install the ESM:
 - a. Ensure that the release levers on the new ESM are in the open position.
 - b. Gently slide the ESM into the enclosure until the ESM stops.
 - c. Push the release levers to the closed position.
 - d. Reconnect the SAS cable or cables to the ESM using the location information marked on each cable in step 3a.

Attention: Incorrect cable placement might result in data loss.

e. If this service action was a nonconcurrent repair, restore power to the power supplies of the disk drive enclosure and power on the system or partition.

Note: To prevent loss of enclosure information, do not replace both ESMs at the same time with the power off. To replace the second ESM nonconcurrently, restore power first. Then remove power and replace the ESM.

Removing and installing a midplane

You can service the midplane nonconcurrently.

Attention: Failure to follow the steps sequentially for this field replaceable unit (FRU) removal or installation might result in damage to the FRU or system.

Use the following precautions whenever you handle electronic components or cables:

- Attach a wrist strap to an unpainted metal surface of your hardware to prevent electrostatic discharge (ESD) from damaging your hardware.
- If you do not have a wrist strap, before removing the product from ESD packaging and installing or replacing hardware, touch an unpainted metal surface of the system for a minimum of 5 seconds.
- Keep all electronic components in the shipping container or envelope until you are ready to install them.
- If you remove and reinstall an electronic component, temporarily place the component on an ESD pad or blanket, if available.
- Replace only the midplane FRU in this procedure until power has been applied to the disk drive enclosure with the new midplane installed. The original enclosure services managers (ESMs) must be used in this procedure to preserve the serial number.

To remove and install a midplane, complete the following steps:

- 1. Remove power to the disk drive enclosure to service the midplane. Removing power to the disk drive enclosure might require powering off the system or partition that is using the disk drive enclosure. Remove power from both power supplies of the disk drive enclosure.
- 2. Carefully remove each disk drive and label it with the slot from which it was removed. See "Removing and installing a disk drive" on page 3. After the midplane is replaced, the disk drives must be inserted back into the same slots from which they were removed.
- **3**. Remove the two power supplies. For instructions, see "Removing and installing a power supply" on page 8.
- 4. Label and remove all SAS cables to the ESMs.
- 5. Remove both ESMs. For instructions, see "Removing and installing an enclosure services manager" on page 4.
- 6. Remove the bezels and unscrew the drawer from the rack.
- 7. Remove the midplane assembly screws.
 - **a**. Remove the enclosure from the rack, turn it upside down, and place the enclosure on a flat surface.
 - b. Using the correct size screwdriver, remove the two screws from the bottom of the enclosure. Label these screws as to the location from which they are removed and place them aside.
 - **c.** Turn the enclosure top side up and place it on a flat surface. Remove the four beveled screws on the right and left sides that secure the midplane assembly to the front of the enclosure. Label the four screws with the location from which they are removed and place them aside.
 - d. Remove the four screws on the right and left sides of the enclosure that secure the midplane assembly to the chassis. Label the four screws with the location from which they are removed and place them aside.






Figure 4. Removing the midplane assembly screws



- 8. Remove the midplane assembly.
 - a. Rotate the midplane assembly up about 45 degrees.
 - b. Lift the midplane assembly out of the enclosure.



- 9. Install the midplane assembly.
 - a. Grasp the midplane assembly with two hands and hold it at a 45 degree angle.

- b. Insert the three tabs on the midplane assembly into the tab holes in the enclosure and rotate the front of the assembly down.
- 10. Install the midplane assembly screws.
 - **a**. Secure the midplane assembly to the chassis on both the right and left sides of the enclosure by using the four screws that you removed earlier in step 7d.
 - b. Insert the four beveled screws that secure the midplane assembly to the front of the enclosure by using the four screws that you removed earlier in step 7c.
 - **c.** Turn the enclosure upside down and insert the two screws on the bottom of the enclosure by using the two screws that you removed in step 7b.
 - d. Turn the enclosure top side up and install the enclosure in the rack.
- 11. Screw the drawer into the rack and install bezels.
- 12. Install both of the original ESMs. For instructions, see "Removing and installing an enclosure services manager" on page 4.
- 13. Install SAS cables to the ESMs.
- 14. Install both original power supplies. For instructions, see "Removing and installing a power supply."
- **15**. Install the disk drives making sure that each disk drive is inserted back into the same slot from which it was removed. For instructions, see "Removing and installing a disk drive" on page 3.
- **16**. Restore power to the power supplies of the disk drive enclosure and power on the system or partition.
- 17. Check the LEDs to make sure that the enclosure is fully operational.

Removing and installing a power supply

You can remove and install a power supply concurrently or nonconcurrently.

Attention: Failure to follow the steps sequentially for this field replaceable unit (FRU) removal or installation might result in damage to the FRU or system.

Use the following precautions whenever you handle electronic components or cables:

- Attach a wrist strap to an unpainted metal surface of your hardware to prevent electrostatic discharge (ESD) from damaging your hardware.
- If you do not have a wrist strap, before removing the product from ESD packaging and installing or replacing hardware, touch an unpainted metal surface of the system for a minimum of 5 seconds.
- Keep all electronic components in the shipping container or envelope until you are ready to install them.
- If you remove and reinstall an electronic component, temporarily place the component on an ESD pad or blanket, if available.

To remove and install a power supply, complete the following steps:

- 1. Determine whether the repair can continue concurrently. To continue the repair concurrently, the following conditions must be true:
 - A second power supply must already be installed.
 - The second power supply LEDs must be set as follows:
 - The dc power LED (green) is on solid.
 - The fault LED (amber) is off.
 - The ac power LED (green) is on solid.

Note: If you decide to remove and replace the failing power supply with the power on, the procedure must be performed in less than 15 minutes to prevent overheating.




Figure 5. Rear view of power supply

- 2. If any of these conditions are not true, continue the repair only after powering off the unit containing the FRU that is being repaired, and begin with **The power supply will be serviced nonconcurrently**. Otherwise, continue with **The power supply will be serviced concurrently**.
 - The power supply will be serviced concurrently. Do not remove power from the working power supply during this procedure. Remove the power-cable retention bracket. Label and remove the power cable from the power supply to be removed. Go to step 3.
 - The power supply will be serviced nonconcurrently.

Power off the system or partition that is using the disk drive enclosure. Remove the power-cable retention brackets. Label and remove the power cables from the power supplies of the disk drive enclosure. Go to step 3.

3. Remove the power supply:

Note: If you are removing the power supply with the power on, this operation must be performed within 15 minutes to prevent overheating.

- a. On the left side of the power supply, press the orange release tab to the right, just enough to release the handle as you rotate the handle downward.
- b. Using the handle, gently slide the power supply out of the enclosure, supporting the bottom.




Figure 6. Removing the power supply

- 4. Install the power supply:
 - a. Hold the replacement power supply so that the handle is fully extended downward.
 - b. Gently slide the power supply into the enclosure until it stops.

- c. Rotate the handle upward into the closed position until it clicks.
- d. Reconnect the power cable to the power supply. Install the power-cable retention bracket.

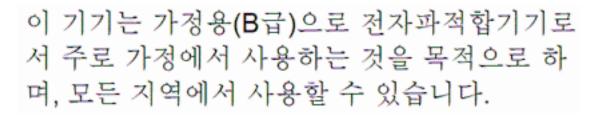
