# Introduction

This chapter provides an overview of the Matrox Monarch LCS Radar central monitoring utility. It includes the supported operating systems and web browsers.

## Matrox Monarch LCS Radar overview

Matrox Monarch LCS Radar is a server-based web application that you can use to monitor and control all the Monarch LCS devices on a network. You install Radar on a server machine that has network access and permission to "see" all the network's Monarch devices. With the Radar application running on the server, open a web browser on a client machine to access the Radar user interface. From there, you can monitor your Monarchs and perform certain basic functions such as rebooting or updating devices.

# Supported operating systems and web browsers

Monarch LCS Radar uses a server/client relationship to view and control Monarch devices. System requirements are different for the server and client machines.

#### Server machine requirements

The server machine has the following requirements:

- Microsoft Windows 10 has been tested and validated for use with LCS Radar.
- Monarch LCS Radar will install on Microsoft Windows 7, Windows 8, or Windows 8.1, but these operating systems have not been formally tested.

#### **Client machine requirements**

Since you access the Monarch LCS Radar through a web browser, most common operating systems and web browsers will work, however the following operating systems and browsers have been tested and validated:

- Devices and operating systems:
  - Microsoft Windows machines running Windows 7 or later
  - Apple devices running iOS 10 or later
  - Android devices running Android 6.0 "Marshmallow" or later
- Web browsers:
  - Google Chrome
  - Mozilla Firefox

# CHAPTER 2

# Installing Matrox Monarch LCS Radar

This chapter describes how to install Matrox Monarch LCS Radar on a server machine, and how to access and log on to the web-based application from client machines.

# **Installing Matrox Monarch LCS Radar**

The Monarch LCS Radar installation program is intended for a server machine. You run the installation program to install a command-line application, which must be kept running in the background on the server machine. Client machines cannot log on to Monarch LCS Radar unless the background application is running.

To install Monarch LCS Radar, follow the steps below:

- **Step 1.** Download the Monarch LCS Radar installation program from the support page of the *Matrox website*.
- **Step 2.** From the machine that will function as the server machine, run the installation program.

*More info:* The server machine must have administrator rights, and must have network access to all Monarch devices on the network.



**Step 3.** Click **Next**, accept the license agreement, then follow the instructions in the installation program.

Step 4. When the installation is complete, select Launch Radar, then click Finish.



More info: If you do not allow the installation program to launch LCS Radar automatically, do not forget to launch it yourself after the installation program is complete.

If you selected Launch Radar in the previous step, the commandline application will open.



More info: This window must remain open in the background on the server machine to allow access to LCS Radar. You can close LCS Radar by pressing **Ctrl + C**.

Result of this task: Monarch LCS Radar is installed.

When done, remember: Monarch LCS Radar must be kept running on the server machine at all times for the application to see and control connected Monarch devices.

# Logging on to Matrox Monarch LCS Radar

After you have installed Monarch LCS Radar on the server, the command-line application should automatically be running in the background. You can then access the Monarch LCS Radar from your web browser.

To log in to LCS Radar, follow the steps below:

- **Step 1.** Open your web browser. For more information see "*Supported operating systems and web browsers*" on page 2. .
- Step 2. Type the server machine's IP address into the web browser's address bar followed by the port number 8080 (e.g. 192.168.12.345:8080), then press Enter.

Step outcome: The Monarch LCS Radar log on page appears.

Step 3. Enter the default username and password "admin/admin" then press Enter.

Result of this task: You are logged in to Monarch LCS Radar.

*When done, remember:* Go to the *Settings page* to change the default username and password to something more unique and secure.

## **Uninstalling Matrox Monarch LCS Radar**

You can uninstall Monarch LCS Radar like any other program installed on your Windows machine.

Step 1. Close the Monarch LCS Radar application by pressing Ctrl + C while the command line window is open.
 Step 2. Go to Start > Programs and Features.
 Step 3. Find Monarch LCS Radar from the programs list
 Step 4. Click Uninstall.

# Using Matrox Monarch LCS Radar

This chapter describes the Monarch LCS Radar user interface, and explains how to perform key tasks.

# **Setting up Monarch LCS Radar for monitoring**

When you first launch Monarch LCS Radar, you'll need to properly set it up to monitor Monarch devices on your network.

To set up Monarch LCS Radar, follow the steps below:

	Step 1.	If LCS Radar is not already running on your server machine, go to <b>Start &gt; All Programs &gt; Matrox Monarch LCS Radar</b> , then click <b>Start Radar</b> .
	Step 2.	Open your web browser, and go to the IP address of your server machine while specifying port 8080.

1. If you have arranged your Monarch devices into groups, you can filter the *Home page* to display your grouped devices only, or to display all of them.

Note: Some antivirus programs may not allow video preview to be displayed if running in the background. 2. This is the video preview of the selected Monarch device. A preview will be displayed when the Monarch is actively encoding, or when the Monarch is idle but has a working video feed connected to it.

Video preview is not displayed is certain cases. For more information, see "*Preview window limitations*" on page *10*.

- 3. This is the list of Monarch devices discovered by LCS Radar. The different columns provide details on each device. Colored rows indicate the following:
  - White: Monarch is idle.

- **Pink:** Monarch is offline.
- **Green:** Monarch is encoding (i.e. streaming and/or recording).
- **Yellow:** Monarch is experiencing an error.
- 4. These are the different actions you can perform on your Monarchs. Click **Show/hide actions** to expand or collapse the options. Select one or more Monarchs from the list to perform the following actions:
  - Remove from list Removes the selected Monarch(s) from the list of devices.
  - **Reset** Resets the selected Monarch(s) to factory default settings.
  - Restore Resets the settings on all the selected Monarch(s) except the IP mode (DHCP or Static).
  - **Reboot** Reboots the selected Monarch(s). Settings are not changed.
  - **Update** Updates the selected Monarch(s). If you click **Update**, this button will change to **Stop update**.
- 5. These are the different columns you can display in the table. Click **Show/hide columns** to expand or collapse the column headings.
- 6. Displays a list of daily scheduled events and Monarch device information.
- 7. Displays the Monarch logs. Click **Save** to save the logs to a *.csv* file.

#### **Preview window limitations**

The Monarch LCS Radar video preview is **not** displayed in the following cases:

- When **both** encoders are enabled, and:
  - The encoding resolution of both encoders is greater than 1280 × 720, with one of the encoders set to RTMP mode.
  - The encoding resolution of encoder 1 or encoder 2 is 1280 × 720p @ 50 fps or 60 fps
  - The encoding resolution of both encoders is greater than 1280 × 720, and at least one encoder's framerate is set to 50 fps or 60 fps.
  - The Monarch is in **Switcher**, **Picture-in-Picture**, or **Side-by-Side** modes, the encoding resolution of both encoders is greater than  $1280 \times 720$ , and the input resolution is greater than  $1280 \times 720p$  @ 50 fps.
- When the Monarch is in **Switcher** mode, with interlaced video at the input, and at least one encoder set to an encoding resolution greater than 1280 × 720.
- When the Monarch is in **Dual-isolated** mode, and the **HDMI Output** setting is set to **From input A or B**.

## **Groups page**

The **Groups** page is where you can group your Monarch devices into categories, making it easier to monitor your devices on the *Home page*.

- 2. The list of IP ranges and/or IP addresses you added for discovery. If you select a group from the **In group** column, the discovered devices will be added to that group when you click **Scan for devices**.
- 3. Click **Scan for devices** to discover (i.e. connect to) the Monarch devices you added to the list. This will add the Monarch devices to the *Home page* so you can monitor them and perform certain actions.
